## CHRIST CHURCH CHRISTIANA HUNDRED Finance Committee Meeting June 20, 2024

The meeting was called to order in person at 6 PM by Marissa Stipa.

Finance Committee members in attendance: Mark Parsells (Treasurer), Bob Reardon (Assistant Treasurer), Marissa Stipa (Chair), Ted Ledden, Terri Carpe (Finance Manager, Breakwater), Allison Ayers, Ruth Beresford (Rector), Jaq Whalen, Hardy Drane (arrived 6:15), Barbara King (arrived 7:00)

Absent: Bill Jones, Christine Cook, Derek Anderson

With a quorum of the Finance Committee, Ruth opened the meeting with a prayer. The minutes of the May 23, 2024 meeting were reviewed and unanimously approved.

Mark reviewed the Treasurer Report as of June 20, 2024. With May's full month report, income was 17.7% over 2023 and 4.1% above budget. As of June 19, 2024, income is up 21.8% and up 3.5% above budget. A contributor completed their 2024 pledge commitment early which contributed to the favorable numbers. There are 422 pledging families.

A new member of the congregation has offered to assist/update Planned and Legacy Giving with his experience with a previous congregation. Ted Ledden and Barbara King have volunteered to participate with that committee along with Deb Piper.

Marissa Stipa is resigning as Convener/Chair of the Finance Committee after three years of service. Christine Cook has accepted the position of Convener/Chair going forward.

Bob closed the meeting with a prayer. The meeting adjourned at approximately 7:10 PM. The next tentative meeting will be scheduled in August with date and time to be determined. There will be no Finance Committee meeting in July.
